**RE: FILM PERMISSION FOR Q&A EVENTS**

BAFTA hereby grants to the Company a non-exclusive permission to film Q&A events relating to films screened as part of the EE British Academy Film Awards season, at BAFTA and at other venues. All rights, title and interest in the filmed Q&A material shall be vested solely in the Company, its subsidiaries and/or affiliated companies.

BAFTA members must be made aware that filming is taking place and that filmed materials may be distributed online and elsewhere. The Company agrees to place notices to this effect on all doors of all screenings where filming takes place and, where possible, inform members in advance by email. The Company confirms that it will arrange for production insurance, employers liability and/or public liability as appropriate for the Q&A event.

No commercial display or appearance of the BAFTA logo is permitted.

If the Q&A Material is used and/or edited, the Company hereby agrees that such editing will not bring BAFTA (or its members) into disrepute. The Company shall indemnify, defend and forever hold BAFTA harmless against and from any and all claims, costs, liabilities, judgements, damages and expenses arising out of any usage of the filmed Q&A Material by the Company and/or any breach by the Company of this agreement. The use of the footage, whether public facing or not, should not be seen to be endorsed by BAFTA.

The Company hereby grants BAFTA the non-exclusive right in perpetuity to exhibit or make available the filmed Q&A Material free of charge, as part of BAFTA's educational remit. This material may be used online and/or in any and all media now known and hereafter invented as BAFTA sees fit, and for the avoidance of doubt the right to edit and to use on public facing sites including with current or future partners. The Company agrees to deliver a high-res digital copy of the rushes of the Q&A or a raw file no later than a month after the recording or by 23 March 2022, whichever is sooner.

In the event that the Company wishes to exploit the filmed Q&A Material commercially, including but not limited to DVD extras, the Company hereby agrees to notify BAFTA of such intended usage and to pay the following one-off fee to BAFTA prior to such usage as follows: \$5,000.00 (for three years' term), \$7,500.00 (for five years' term), \$22,000.00 (for perpetuity). Please note that these are minimum payments for commercial use of BAFTA content and that final costs are determined by the usage and territories that a licence requires.
